Position Summary:

Applications are invited for the position of Head of Landscape Architecture to be appointed at the level of Associate Professor or Lecturer/Assistant Professor, subject to qualifications and experience of the successful candidate. The successful candidate will lead a team of Landscape Architecture Faculty and Design Fellows and will provide an important leadership role in the subject by, *inter alia*, fostering a collaborative research culture, promoting a research-informed curriculum to address contemporary challenges including climate change, translating the fruits of research into innovation and impact, and promoting and growing the subject area. The successful candidate will contribute to the Landscape Architecture programme, as well as contributing to the School, the College of Engineering and Architecture, and the wider University.

Applicants will hold a PhD in landscape architecture, landscape planning, environmental design or a related land use discipline, have a demonstrable commitment to evidence-based research and publication, a track record of research funding applications, and an ability to contribute research in an area that complements the research profile of the school. Applicants will be committed to high-quality teaching at University level, possess excellent interpersonal skills, demonstrated commitment to, and experience of, academic leadership and awareness of equality, diversity and inclusion.

Applicants will have a capacity and enthusiasm for working in an interdisciplinary context in the School of Architecture, Planning and Environmental Policy, the University research institutes and the wider academic community. Candidates with a research expertise in one or more of the following, or related areas, are particularly welcome:

- Environmental Design
- Landscape Planning
- Green Infrastructure and Climate Adaptation
- Rural Land Use Change and Management

The School of Architecture, Planning and Environmental Policy has an international reputation as a centre of excellence for research and teaching in a multidisciplinary School ranked in the QS top 150. The School offers the only Landscape Architecture programme in Ireland, with the School having established an excellent reputation for design excellence with its faculty and adjunct staff maintaining an international profile. The School is located in the College of Engineering and Architecture which was awarded an Athena SWAN bronze award in 2019 for its shared commitment to ensuring that their faculty, staff and students experience an equal, diverse and inclusive environment.

Important Note: The most appropriate candidate will be appointed to the position, at the grade commensurate with their career stage, experience and achievements. For appointment at the level of Lecturer/Assistant Professor,

a candidate will be working at the level of satisfactory achievement in terms of respective indicators for Research, Teaching, and Leadership and Contribution across the mandatory selection criteria. For appointment at the level of Associate Professor, a candidate will be expected to be working at the level of substantial achievement as set out in the [UCD Development Framework for Faculty](#) and, therefore, will significantly surpass the mandatory requirements in the selection criteria below.

Principal Duties and Responsibilities:

The duties of the successful candidate will include, but not necessarily be limited to, the following:

- Undertake and publish high-quality research in international journals and books;
- Actively contribute to the teaching programmes in the School, including module design and delivery, examination and assessment, quality assurance and enhancement and associated administrative duties;
- Supervise Master and Doctoral research students;
- Generate research funding to facilitate an active research programme and support graduate students;
- Have impact through research, innovation, and transfer to practice and policy;
- Contribute to the academic life of the Schools, College, the University and its research institutes;
- Contribute to the wider educational community;
- Develop international links and attend research meetings, conferences and workshops;
- Participate in School/College/University committees and boards, and undertaking associated administrative activities;
- Provide academic leadership as Head of Landscape Architecture and contribute to the strategic development of the subject area and School.
- Undertake such other appropriate duties as directed by the Head of School in line with the contract of employment.

Selection Criteria:

Selection criteria outline the qualifications, skills, knowledge and/or experience that the successful candidate would need to demonstrate for successful discharge of the responsibilities of the post. Applications will be assessed on the basis of how well candidates satisfy these criteria.

- A proven commitment to evidence-based research and a track record of high-quality publications, commensurate with stage of career
- A track record of research funding awards, commensurate with stage of career
- A track record of research supervision and management in an area that strengthens or strategically complements the research profile of the School
- Evidence of high-quality university-level teaching, learning and student support
- A capacity and enthusiasm for working in an interdisciplinary context to promote policy and/or practice impact
- Excellent interpersonal skills and a strong capacity to communicate evidence-based research to policy as well as practice audiences
- A demonstrated commitment to, and experience of, academic leadership through organisation of research and curriculum/programme development.
- A demonstrated ability to contribute positively to fostering an inclusive environment and a level of awareness of equality, diversity and inclusion.

Desirable:

Athena SWAN at UCD

University College Dublin has received its second Athena SWAN Bronze institutional award in recognition of the university’s work towards gender equality. To achieve this accreditation, an institution must demonstrate that it has undertaken a thorough self-assessment of gender equality challenges and has developed a detailed action plan to tackle them. The [UCD Gender Equality Action Plan 2020-2024](#) was prepared by the [Gender Equality Action Group](#) and its Working Groups, in a process that involved external benchmarking, an EDI employee survey, focus groups and consultation across the university. Eligibility to compete and certain restrictions on eligibility

Incentivised Scheme for Early Retirement (ISER):	It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position

<p>Department of Health and Children Circular (7/2010):</p>	<p>The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider public service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years, after which time any re-employment will require the approval of the Minister for Public Expenditure and Reform. People who availed of either of these schemes are not eligible to complete in this competition.</p>
<p>Collective Agreement - Redundancy Payments to Public Servants:</p>	<p>The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the public service by any public service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. Thereafter the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility) and the Minister’s consent will have to be secured prior to employment by any public service body.</p>
<p>Declaration:</p>	<p>Applicants will be required to sign a Pre-Employment Declaration to confirm whether they have previously availed of a public service scheme of incentivised early retirement and/or the collective agreement outlined above. The above represents the main schemes and agreements restricting a candidate’s right to be re-employed in the public service. However it is not intended to be an exhaustive list and candidates should declare details of any other exit mechanism they have availed of which restricts their right to be re-employed in the public service. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.</p>
<p>Superannuation and Retirement:</p>	<p>The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the University, at the time of being offered an appointment. In general, and except for candidates who have worked in a pensionable (non-single scheme terms) public service job in the 26 weeks prior to appointment (see paragraph d below), this</p>

means being offered an appointment based on membership of the Single Public Service Pension Scheme (“Single Scheme”).

Key provisions attaching to membership of the Single Scheme are as follows:

a. Pensionable Age - The minimum age at which pension is payable is 66 in line with State Pension age changes.

b. Retirement Age - Scheme members must retire at the age of 70.

c. Pension Abatement:

- If the appointee was previously employed in the Civil Service or in the Public Service please note that the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 includes a provision which extends abatement of pension for all Civil and Public Servants who are re-employed where a Public Service pension is in payment. This provision to apply abatement across the wider public service came into effect on 1 November 2012. This may have pension implications for any person appointed to this position who is currently in receipt of a Civil or Public Service pension or has a preserved Civil or Public Service pension which will come into payment during his/her employment in this position.
- Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007
The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person’s 60th birthday, whichever is the later, but on resumption, the pension will be based on the person’s actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).
- Ill-Health-Retirement
Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

d. Prior Public Servant - While the default pension terms, as set out in the preceding paragraphs, consist of Single Scheme membership, this may not apply to certain appointees. Full details of the conditions governing whether or not a public servant is a Single Scheme member are given in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. However the key exception case (in the context of this competition and generally) is that a successful candidate who has worked in a pensionable (non-single scheme terms) capacity in the public service within 26 weeks of taking up appointment, would in general not become a member of the Single Scheme. In this case such a candidate would instead be offered membership of the UCD Pension Scheme. This would mean that the abatement provisions at (c) above would apply, and in addition there are implications in respect of pension accrual as outlined below:

e. Pension Accrual - A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one existing public service pension scheme would apply. This 40-year limit, which is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012 came into effect on 28 July 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

f. Pension-Related Deduction - This appointment is subject to the pension-related deduction in accordance with the Financial Emergency Measure in the Public Interest Act 2009.
